Item 2 Minutes Update and Approval (14/09/16)

- Minutes agreed.
- Member applications received from the Chair and TW.
- Application forms to be sent to all other Board members – **Deadline Wednesday 11 January 2017**
- Parking letter to council from Multiple Retailers (MR) will be put on hold until the next MR meeting in January 2017.
- Proposals have been made to the council regarding Christmas parking offers – Free after 12pm on Saturday 3 December 2016 and £3.50 per day in the Swannery Car Park.
- Town Wi-Fi may become a collaboration with Dorchester, Weymouth and Portland.

Item 4 Chairman Verbal Update

- Night Time Economy (NTE) for New Year's Eve will recommend the use of breathalysers.
- Under Purple Flag Weymouth is potentially looking to install a Town Centre Manager/Night Time Manager.
- The Clipper is being looked at as a Media Centre/Start Up Centre for media training and small business development. This would be as a grant funded application.

Item 5 BID Manager Update

- **BID Levy**
 - BID Levy final reminder has been sent out.
 - BID Levy FAQ's on the Weymouth BID website to be reviewed and updated.
- **Appearance of the Town**
 - Meter cupboards and Argos wall have been cleaned.
 - Area by B&Q and KFC requires improvement.
 - Photographs to be taken to highlight areas that need cleaning/tidying up.
- **Christmas and New Year**
 - First Bus looking to extend bus running times for New Year's Eve.
 - No BID plans for NYE.
- **Training**
 - Weymouth College has launched its Business Training Programme. Funding from the BID is limited until March 2017.
- **Meeting with WPBC**
 - This will discuss how the Councils strategies, master plan and policies link in to the Business Community including Rangers, Town Centre Management, Enforcement of Bye Laws and Waste Disposal.
- **Rateable Values**
 - Values have been reassessed for 2017 with values going both up and down.
 - Small Business Rate relief is moving to £12,000.
 - If approached by Levy Payers regarding increases in rateable value the BID is able provide a contact for advice.
- **Income and Grant generation**
 - BID PR and Marketing contract with Popcorn Marketing has changed focus to Sponsorship.
 - Proposal for a 6 month contract with R Barton Consultancy to deliver additional grant funding income to the BID. Voted yes by the committee.
- **BID Renewal**
 - Recommend that a consultation process begins in January 2017.

- **FEAST – Monday 3 October – Friday 25 November 2016**

- **Waterfest 2017**
 - A report was presented to the Board to discuss the future of Waterfest.  - Lights – Simple lighting to be added in gaps where there is no lighting. Trinity Road lights on lamp posts. St Thomas Street will be completely lit up. The trees is St Mary Street and St Thomas Street will be lit up. The installation costs are to be shared by the BID and WPBC.
 - 36 lit Christmas Trees will be on display throughout the town.
 - Ice Rink – staff has been organised. Security arranged with reduced hours from last year. Insurance has been arranged. This year the chillers can cool to a temperature of -20.
